LIBRARY DIRECTOR'S ORAL REPORT:

Reported on the MARINet, NorthNet meeting that was held in January.

- Updated the library board about the ongoing issues with publisher's embargos on the purchasing of eBooks and eAudiobooks with Overdrive.
- NorthNet's disaster plan and looking into Larkspur Library's disaster plan.
- Summer Lunch Program and the possibility of starting a program in Larkspur.

Reported on the contributions of the Larkspur Library Foundation

 The Larkspur Library has contributed \$41K to the libraries operating and materials budget for the past 5 years. Going forward the library will be making sure that the Foundation's or any partner's contribution is visibly noted with a book plate or logo added to a digital content.

 - Director Escobedo updated the Library Board on the progress of the recruitments and that eight applicants had extended an invitation to the first interview. He also reported that the job descriptions and procedures for hiring new hourly/parttime employees was being updated and revised.

 - Reviewed upcoming events that were in the works.
 - Current recruitments for teen volunteers for Teen Tech Helpers.

- Friends of the Library started a mailing campaign, targeting, Larkspur,
 Greenbrae, and Kentfield. Friends are working on a business campaign with the Commons Foundation. Working on a membership event with author Julia Flynn Siler.
- Larkspur Library Foundation: reported on getting sponsorship Fairway Capital, College of Marin, and *MarinIJ* for ads to spread awareness of the Larkspur Foundation.
- The Commons Foundation they've begun a capital campaign with a goal of

raising five million dollars.
