MEETINGS OF THE GENERAL PLAN STEERING COMMITTEE AND PUBLIC WORKSHOPS

1. Kickoff Meeting

Monday, February 27th 6:30 pm, City Council Chambers

Topics covered: Overview of general plan law, purpose, and applicability. Review structure of 1990 General Plan and work done to date by the Citizens Advisory Committee (CAC) in General Plan Update process, and discuss how General Plan policies impact the City on a day-to-day basis. Review changes to State law, for General Plan, studies in need of updates and completion, 20-year time horizon, timeline of General Plan Update process, and distribution of materials for Land Use Element discussion.

2. Land Use Element

Tuesday, March 6th 6:30 pm, City Council Chambers

Topics covered: Overview of land use in Larkspur's General Plan including consistency with 2015-2023 Housing Element and Special Area Plans (Downtown Plan and CLASP), Sea Level Rise Vulnerability Assessment, and discussion on Special Area Plan for North Magnolia Avenue Commercial Area.

3. Optional Elements

Tuesday, March 20th 6:30 pm, City Council Chambers

Topics covered: Overview of additional elements suggested under California's General plan Guidelines, and options for addressing relevant topics, such as sustainability, GHG reduction, and economic development, within the context of the Larkspur General Plan Update.

4. PUBLIC WORKSHOP: Sea Level Rise, Health & Public Safety, and Noise

Topics covered: Review applicable state laws (AB 32, SB 375, and others) regulating climate change and discuss the existing and future policies and programs established in the City's Climate Action Plan and in the CAP update. Review draft goals for public health & safety, and noise standards.

5. Health & Public Safety Element and Noise Element

Topics covered: Overview of public health and safety issues addressed in the Draft General Plan Update, including natural hazards, sea level rise, noise, and land-use compatibility. Review of Marin County Sea Level Rise Vulnerability Study (June 2017).

6. PUBLIC WORKSHOP: Circulation Element

Topics covered: Discuss how vehicles, buses, pedestrians, and bicyclists interact on the City's circulation and transportation routes. Discuss how current and future development patterns influence traffic flow, congestion, and the safety of all users of the transportation system. Review of traffic limit policies for area north of Corte Madera Creek, circulation policies of the draft SMART Station Area Plan to be considered, Levels of Services (LOS) standards and new State mandates and thresholds for Vehicle Miles Traveled (VMT).
