ORDINANCE 1049**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LARKSPUR  
AMENDING SECTION 2.18.010, "HERITAGE PRESERVATION BOARD  
ESTABLISHED," OF THE LARKSPUR MUNICIPAL CODE TO REDUCE THE  
MEMBERSHIP OF THE BOARD FROM SEVEN TO FIVE VOTING MEMBERS**

**WHEREAS**, the Heritage Preservation Board is currently comprised of seven (7) voting members and one non-voting ex-officio member of the Planning Department;

**WHEREAS**, the majority of the City of Larkspur's Boards and Commissions are comprised of five (5) voting members;

**WHEREAS**, at the February 5, 2020, regular meeting, the Larkspur City Council approved a statement of the Council's intention to reduce the voting membership of the Heritage Preservation Board from seven (7) to five (5) voting members through not filling the next two occurring vacancies on the Board; and

**WHEREAS**, there currently exists two voting member vacancies on the Board.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LARKSPUR DOES HEREBY ORDAIN AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated herein by reference.

**Section 2. Amendment to Municipal Code.** The City Council hereby amends § 2.18.010 of the Larkspur Municipal Code to read as follows:

**2.18.010 Heritage Preservation Board Established.**

In accordance with and subject to the provisions of Larkspur Municipal Code Chapter 2.48, a Heritage Preservation Board is established and shall be referred to as "Board" in this chapter. The Board shall have five (5) ~~seven (7)~~ voting members and one nonvoting ex officio member who is a member of the Planning Department. Voting members shall be selected on the basis of demonstrated interest, competence and knowledge in historic preservation.

**IT IS HEREBY CERTIFIED** that the foregoing ordinance was duly introduced at a regular meeting of the Larkspur City Council held on June 17, 2020, and thereafter passed and adopted by the Larkspur City Council at a regular meeting on July 1, 2020, by the following vote:
