



**NOTICE OF PUBLIC HEARING
HERITAGE TREE REMOVAL PERMIT
September 15, 2022, at 6:30 p.m.**

The August 18, 2022, meeting on this application has been rescheduled due to a change in the Zoom Meeting ID that prevented the public from attending the meeting.

On September 15, 2022, at 6:30 p.m. the Larkspur Parks and Recreation Commission will hold a public hearing to consider the Heritage Tree removal application of Adam Politzer for **398 N. Almenar Drive, Greenbrae**. The applicant proposes to remove six of twelve Heritage-size Coast Redwood trees (*Sequoia sempervirens*), with circumferences between 50 and 91 inches. A certified arborist indicates the trees are “uplifting and cracking the asphalt driveway, creating serious trip-and-fall hazards” and the trees cannot be safely pruned to repair and preserve the driveway. The applicant indicates the trees have caused damage to the house foundation and sewer line. If approved, the property owner intends to remove the trees outside of bird nesting season. At this hearing, the applicant will present their case for removal and any interested parties may speak for or against the application. The Commission will consider if the tree removal findings in Larkspur Municipal Code Section 12.16.070(F) can be made. The decision of the Commission may be appealed to the Larkspur City Council within 15 calendar days of the decision by filing an appeal with the City Clerk.
