**SUMMARY AND BACKGROUND**

The County of Marin has advised the City that a resolution should be passed annually to continue the fee.

Adoption of this resolution will allow the continuance of the Clean Storm Water Activity Fee to fund storm water activities. Up to \$97,000 in revenue would be raised during the 2019/20 fiscal year to fund storm drain cleaning and clean water activities as per the program instituted in 1995.
